Note: NORC data for 2004 and 2006 are weighted data as necessitated by changes in sampling design in that year; all other data are unweighted.

Spending on Blacks (NORC): "We are faced with many problems in this country, none of which can be solved easily or inexpensively. I'm going to name some of these problems, and for each one I'd like you to tell me whether you think we're spending too much money on it, too little money on it, or about the right amount of money ... Improving the conditions of blacks. Are we spending too much, too little, or about the right amount on improving the conditions of blacks?"

Help Blacks (NORC): "Some people think that African Americans have been discriminated against for so long that the government has a special obligation to help improve their living standards. Others believe that the government should not be giving special treatment to African Americans. Where would you place yourself on this scale, or haven't you made up your mind on this?" (Show card)

Aid to Blacks (ISR): "Some people feel that the government in Washington should make every possible effort to improve the social and economic position of blacks.
